Daily Price Limits	<p>Whenever the price moves by 15% in either direction from the previous day's settlement price, trading at or within the price limit of +/- 15% is allowed for the next 10 minutes. After this "cooling-off" period has elapsed, there shall be no price limit for the remainder of the trading day.</p> <p>There shall be no price limits on the last trading day of the expiring contract month.</p>
Contract Months	2 nearest serial months and 4 quarterly contract months on March, June, September and December cycle.

In the event, that the FSP Day is not or will not be a Singapore Business Day, the FSP Day shall be deemed to be the next immediately available Singapore Business Day following the Last Trading Day.</p>
Position Limit	A person shall not own or control more than 10,000 contracts net long or net short in all contract months combined.
